

CONDITIONS OF ENTRY

[Weekday Giveaway] – Mondays* (*Not including Public Holiday Monday 6th July 2026), Tuesdays, Wednesdays, Thursdays & Fridays in July 2026 – All tiers (Excluding VIP Magnetic, VIP Orpheus & VIP Pelorus)

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

1. Promotional Period and Location

- 1.1. The **[Weekday Giveaway]** promotion (“**Promotion**”) will commence at [09:00] Wednesday 01 July 2026 and concludes once the final prize draw has been conducted at [16:00] Friday 31 July 2026 (“**Promotion Period**”).
- 1.2. During the Promotion Period, Prize Draws will be conducted approximately every 30 minutes from [12:00 – 16:00] (each a “Prize Draw”) on the Main Gaming Floor at The Ville (“Draw Location”) on 1, 2, 3, 7, 8, 9, 10, 13, 14, 15, 16, 17, 20, 21, 22, 23, 24, 27, 28, 29, 30 & 31 July 2026 during the Promotional Period (each a “Draw Day”).

2. Eligibility to Enter

2.1. Participation in the Promotion is open to all persons who:

- a) are 18 years of age or older; and
- b) be a be a current Member, Director, President, Platinum, Chairman or Diamond member of the Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promotor) (each a “**Membership Card**”);
- c) are entitled to access the draw location;
- d) not be the subject of an exclusion direction, exclusion notice or self-exclusion order pursuant to the Casino Control Act 1982 (Qld);
- e) not be subject to restrictions on entering the property such as having been issued a Withdrawal of License; and
- f) not be restricted from accumulating and redeeming any further benefits of their membership through having triggered a Pre – Commitment.

A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.

2.2. The Promoter reserves the right to refuse any person participating in the Promotion at any time.

3. Entries and Entry Periods

3.1. An Eligible Entrant may earn entries in the **Qualifying Prize Draws** through playing Electronic Gaming

Machines (“**EGM**”), Electronic Table Games (“**ETG**”) and Table Games excluding Texas Holdem.

3.2. For **Prize Draws**, one (1) entry (“**Entry**”) will be automatically generated on behalf of an Eligible Entrant for every \$5 Theoretical Spend based on game play (when the Eligible Entrant’s current Vantage Rewards card is correctly inserted into EGM/ETG or registered at a gaming table). Table Games play is based on estimated average bet as determined by gaming staff.

3.3. Entry Periods for the **Prize Draws** are from 09:00 on the day of the draw up until the last Prize Draw at 16:00 (each an “**Entry Period**”). Entries will only qualify for prize draws conducted on that respective day.

3.4. Eligible Entrants must be present to win.

3.5. Eligible Entrants must register their Vantage Rewards card in an EGM within 2 hours prior to the next prize draw to activate entries earned.

5.1. Winners will receive their Prize after their identity has been confirmed in accordance with conditions under item **7. Identification**.

The Promoter cannot guarantee that announcements can be heard in all parts of the Draw Location or throughout the remainder of the Venue during the Prize Draw announcements.
- 6.5. A Drawn Entrant who has entered the Prize Draw must be "present at the Prize Draw" for a chance to win. To be deemed "present at the Prize Draw" the Drawn Entrant must present themselves to The Ville representative at the Draw Location at The Ville within two (2) minutes of their name being announced and provide suitable identification in accordance with conditions under item **7. 7. Identification

- 7.1. An Eligible Entrant must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's license) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
- 7.2. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of an Eligible Entrant is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

8. Invalid Draws/Entries

- 8.1. If an Entry is gained by means other than in accordance with these Terms and Conditions, the Entry will be deemed invalid.
- 8.2. Should the Casino Operator determine that the integrity of the promotion and/or draw has been compromised it may either postpone the promotion and/or draw until such a time as the integrity of the promotion and/or draw has been validated or cancel the draw.

9. General

- 9.1. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
- 9.2. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax liability or implication which attaches to a prize is the responsibility of the Winner claiming that Prize.

- 9.3.
