

CONDITION OF ENTRY

[Vantage Rewards PLUS Program] – Effective as of 1 July, 2026 – Director, President, Platinum, Chairman & Diamond members

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thies Drive, Townsville, Queensland, 4810.

1. Eligibility to Enter

- 1.1. In order to participate in the Promotion, a person must:
 - a) be 18 years of age or over;
 - b) be a current Director, President, Platinum, Chairman or Diamond member of Vantage Rewards program operated by the Promoter and have a current membership card (with selective criteria chosen by the promotor) (each a “**Membership Card**”);
 - c) not be the subject of an exclusion direction or self-exclusion order pursuant to the Casino Control Act 1982 (Qld);
 - d) not be subject to restrictions on entering the property such as having been issued a Withdrawal of License; and

A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.

2. Entries

- 2.1. An Eligible Entrant may earn tier credits through playing gaming machines (“**EGM**”), Electronic Table Games (“**ETG**”) and Table Games
- 2.2. Incentive levels must be reached before relegation date.

3. Prizes

- 3.1. The prize for a Director Member reaching 15,000 Tier Credits is 300 Vantage Dollars awarded once.
