

CONDITION OF ENTRY

[Fortune Idols] – Mondays & Tuesdays in September 2026 - Director, President, Platinum, Chairman or Diamond

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

1. Promotional Period and Location

- 1.1. The Fortune Idols promotion ("**Promotion**") commences at 12:00pm on Monday 7 September 2026 and concludes at 21:15 on Tuesday 29 September 2026 ("**Promotional Period**").
- 1.2. Tournament games will take place on the jackPod machines in the Promo Zone located on The Ville Main Gaming Floor and The Orpheus Room ("**Draw Location**").
- 1.3. Second chance Prize Draws will be conducted on the Main Gaming Floor at The Ville ("**Draw Location**").

2. Eligibility to Enter

- 2.1. In order to participate in the Promotion, a person must:

- a) be 18 years of age or over;
- b) be a current Director, President, Platinum, Chairman or Diamond member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promotor) (each a "**Membership Level**");
- c) are entitled to access the draw location;
- d) not be the subject of an exclusion direction or self-exclusion order pursuant to the Casino Control Act 1982 (Qld);
- e) not be subject to restrictions on entering the property such as having been issued a Withdrawal of License; and
- f) not be restricted from accumulating and redeeming any further benefits of their membership through having triggered a Pre – Commitment.

A person who meets the above criteria will be referred to as an "**Eligible Entrant**".

- 2.2. The Promoter reserves the right to refuse any person participation in the Promotion.

3. Entry and Entry Periods

- 3.1. An Eligible Entrant must present themselves at the jackPod machine in the Promo Zone between 12:00pm to 21:00 on Mondays & Tuesdays in September for each Promotion Period ("**Promotional Period**").
- 3.2. The Promotor will have representatives to assist the Eligible Entrant in playing the jackPod machines with the game "Fortune Idols".
- 3.3. Each Eligible Entrant only qualify to have a maximum of one attempt during each Promotional Period. Once "Fortune Idols" game has been played, an Entrant will receive a second chance ticket for the "Second Chance Draw" which then needs to be placed in the barrel located in each Promo Zone.
- 3.4. Entries close 15 minutes prior to each of the Second Chance Draws.
- 3.5. An Entry is only valid for the Second Chance Draw on that Draw Day and is not valid for any subsequent Prize Draws on other days.
- 3.6. Entries earned are valid for the Vantage Rewards membership level at the time of earning.

4. Prizes

- 4.1. The total prize pool for this Promotion is 70,000 in Vantage Dollars for the Second Chance Draws plus a share of 130,000 in Vantage Dollars for the jackPod prizes awarded within the month.

- 4.2. Winners will receive their Prize after their identity has been confirmed in accordance with conditions under item **7. Identification**.
- 4.3. All Prizes must be taken as stated and cannot be exchanged for alternate prizes or offers. Any tax implication or liability that attaches to a Prize will be the sole responsibility of the relevant winner.

5. Conduct of the Prize Draw

- 5.1. Eligible Entrants who play “Fortune Idols” will be awarded the indicated prize to their account by the Promoter.
- 5.2. The Promoter will conduct the Second Chance Draws approximately at 21:15 (each a “Prize Draw”).
- 5.3. The Drawn Entry must be verified by two (2) representatives of The Ville to ensure the correct name is announced.
- 5.4. The name (and membership number) of the Eligible Entrants identified on the Drawn Entry will be announced on the PA System (“**Drawn Entrant**”). The Promoter cannot guarantee that announcements can be heard in all parts of the Draw Location or throughout the remainder of the Venue during the Prize Draw announcements.
- 5.5. A Drawn Entrant who has entered the Prize Draw must be “present at the Prize Draw” for a chance to win. To be deemed “present at the Prize Draw” the Drawn Entrant must present themselves to The Ville representative at the Draw Location at The Ville within two (2) minutes of their name being announced and provide suitable identification in accordance with conditions under item **7. Identification** (“Winner”).

6. Present at the Prize Draws

- 6.1. If a Drawn Entrant does not comply with **Condition 5.5** at the prize draws, a redraw will take place.
- 6.2. If a Drawn Entrant is not present, a redraw will take place.
- 6.3. If the prize is unclaimed after five (5) redraws, a Hot Seat Draw will be conducted to select the prize winner.
- 6.4. A Hot Seat Draw is conducted using the casino management system to randomly select a player who

has their membership card registered for play on an active gaming machine. The selected player will be the Drawn Entrant for that Prize Draw.

7. Identification

- 7.1. An Eligible Entrant must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's license) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
- 7.2. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of an Eligible Entrant is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

8. Invalid Draws/Entries

- 8.1. If an Entry is gained by means other than in accordance with these Terms and Conditions, the Entry will be deemed invalid.
- 8.2. Should the Casino Operator determine that the integrity of the promotion and/or draw has been compromised it may either postpone the promotion and/or draw until such a time as the integrity of the promotion and/or draw has been validated or cancel the draw.

9. General

- 9.1. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
- 9.2. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the willful or negligent acts or omissions of the Promoter. To avoid any doubt, the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.
- 9.3. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.
- 9.4. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions in its sole and absolute discretion.
- 9.5. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
- 9.6. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion. In the event of any technical difficulties with the kiosk, the Promoter reserves the right to adopt a manual process of generating entries.
- 9.7. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.

The names of drawn entrants will not be published without their consent except as announced at the Draw Location.
