

CONDITION OF ENTRY

[Birthday Bonus] – October, 2023 – All Tiers (Excluding Member)

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

1. Promotional Period and Location

- 1.1. The Birthday Bonus promotion ("**Promotion**") commences at 09:00 on Monday 1 October 2023 and ends at 23:59 Tuesday 31 October, 2023 ("**Promotional Period**").

2. Eligibility to Enter

- 2.1. In order to participate in the Promotion, a person must:
- be 18 years of age or over;
 - be a current Preferred, Executive, Director, President, Platinum, Chairman, Diamond, Magnetic VIP or Orpheus VIP member of Vantage Rewards program operated by the Promoter and have a current membership card (with selective criteria chosen by the promotor) (each a "**Membership Card**");
 - have a birthday that falls within the month of December;
 - not be the subject of an exclusion direction or self-exclusion order pursuant to the Casino Control Act 1982 (Qld);
 - not be subject to restrictions on entering the property such as having been issued a Withdrawal of License; and
 - not be restricted from accumulating and redeeming any further benefits of their membership through having triggered a Pre – Commitment.

A person who meets the above criteria will be referred to as an "**Eligible Entrant**".

- 2.2. The Promoter reserves the right to refuse any person participation in the Promotion.

3. Entries

- 3.1. Eligible Entrants can swipe their Membership Card at the Draw Location during the Promotional Period to participate in the Promotion.
- 3.2. An Eligible Entrant is only entitled to enter the Promotion once during the Promotional Period ("**Prize Draw**").

5. Conduct of the Prize Draw

- 5.1. Eligible Entrants swipe their card at any of the jackPods machines in the Promo Zone during their birthday month to play the game "Birthday Bonus" to redeem their prize

6. Present for the Prize Draws

- 6.1. Drawn Entrants are not permitted to send a proxy to claim a prize.

7. Identification

- 7.1. A Selected Member must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
- 7.2. The Promoter reserves the right to waive or vary the identification requirements in circumstances where the identity of a drawn entrant is determinable without the assistance of a card or other form of identification.

8. Invalid Draws/Entries

- 8.1. If an entry is gained by means other than in accordance with these Terms and Conditions, the entry will be deemed invalid.
- 8.2. Should the casino operator determine that the integrity of the promotion and/or draw has been compromised it may either postpone the promotion and/or draw until such a time as the integrity of the promotion and/or draw has been validated or cancel the draw.

9. General

- 9.1. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
- 9.2. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the willful or negligent acts or omissions of the Promoter. - 9.5. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
- 9.6. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion. In the event of any technical difficulties with the kiosk, the Promoter reserves the right to adopt a manual process of generating entries.
- 9.7. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.

The names of drawn entrants will not be published without their consent except as announced at the Draw Location.
