CONDITION OF ENTRY

1. Promotional Period and Location

- 1.1. The Lucky Harvest promotion ("**Promotion**") commences 09:00 Wednesday 3 April 2024 and concludes at 15:00 on Wednesday 24 April, 2024 ("**Promotional Period**").
- 1.2. Tournament games will take place on the jackPod machines in the Promo Zone located on The Ville Main Gaming Floor and The Orpheus Room ("**Draw Location**").

2. Eligibility to Enter
