CONDITIONS OF ENTRY

[Monday MAYhem] – Mondays in May, 2024 – All tiers (excluding Magnetic VIP and Orpheus VIP)

1. Promotional Period and Location

- 1.1. The **[Monday MAYhem]** promotion ("**Promotion**") will commence at 16:00 on Monday 13 May, 2024 and concludes once the final prize draw has been conducted at 21:00 on Monday 27 May, 2024 ("**Promotion Period**").
- 1.2. Prize draws will be conducted on the Main Gaming Floor at The Ville ("Draw Location").

5. Conduct of Prize Draws
