CONDITIONS OF ENTRY

[Piggy Pays] – April, 2024 – Member, Preferred, Executive, Director & President (Excluding VIP Magnetic & VIP Orpheus)

1. Promotional Period

- 1.1. The **[Piggy Pays]** promotion ("Promotion") commences at [18:00] on Friday 5 April, 2024 and concludes once the final prize draw has been completed on Friday 26 April, 2024. ("Promotional Period").
