CONDITIONS OF ENTRY

1. Promotional Period

- 1.1. The [MAJOR The Crazy Claw Giveaway] promotion ("Promotion") commences at [14:00] on Sunday June 1, 2025, and concludes once the final prize draw has been completed on Sunday 29 June, 2025. ("Promotional Period").
- 1.2. During the Promotion Period, Prize Draws will be conducted approximately every 30 minutes from [14:00 18:30] (each a "Prize Draw") on The Main Gaming Floor at The Ville ("Draw Location") on 1, 8, 15, 22 & 29 June, 2025 during the Promotional Period (each a "Draw Day").

2. Eligibility To Enter

- 3.1. An Eligible Entrant may earn entries in the **Qualifying Prize Draws** through playing electronic gaming machines ("**EGM**"), Fully Automated Table Games ("**FATG**") and Table Games.
- 3.2. **For Prize Draws**, one (1) entry ("**Entry**") will be automatically generated on behalf of an Eligible Entrant for every \$5 Theoretical Spend based on game play (when the Eligible Entrant's current Vantage Rewards card is correctly inserted into EGM/FATG or registered at a gaming table). 7. Identification

- 7.1.
