
CONDITIONS OF ENTRY

[Easter Cash Giveaway] – Saturday 20th April, 2019 – All tier DM Promotion

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

Promotion

1. The [Easter Cash Giveaway] promotion (“**Promotion**”) will commence at [1pm] [Saturday 20 April, 2019] and concludes at the conclusion of the [5pm] Prize Draw on [Saturday 20 April, 2019] (“**Promotion Period**”). All times are listed in Australian Eastern Standard Time.
2. Prize draws will take place on the main gaming floor at The Ville (“**Draw Location**”) on [Saturday 20 April, 2019] (“**Draw Day**”).

Entry requirements

3. Participation in the Promotion is open to all persons who:
 - a. are 18 years of age or older; and
 - b. are members of the Vantage Rewards program operated by the Promoter and have a current Vantage Rewards membership card (with selective criteria chosen by the Promoter) (each a “**Membership Level**”); and
 - c. are entitled to access the Draw Location; and
 - d. are not the subject of an exclusion direction or self exclusion order pursuant to the *Casino Control Act 1982* (Qld); and

People who meet the above conditions and continue to satisfy the conditions during the Promotion Period are referred to as “**Eligible Member/s**” and will be entitled to enter the Promotion.

4. The Promoter reserves the right to refuse any person participating in the Promotion at any time.

Entry into the Prize Draws

5. From 11am (“**Promotion Start Time**”) [Saturday 20 April, 2019], the Promoter will have representatives handing (1) entry (“**Entry**”) for the Draw Day to Eligible Members using the membership records of those Eligible Members that are held by the Promoter.
6. Entry forms are subject to audit for multiple entries by one (1) member. If any member is found to have submitted more entries than distributed, any winnings from that promotion will be forfeited.
7. To enter the prize draws:
Eligible Members must place their Entry in the barrel from 11am at the Draw Location up to one minute prior to each Prize Draw (each an “**Entry Period**”) to enter the prize draws on Saturday 20 April, 2019.
8. Only one (1) Entry for the draw day will be issued to each Eligible Member for the Promotion and an Eligible Member is only entitled to enter the Promotion once for the Draw Day. Should an Eligible Member become a Winner, their Entry will not be re-entered into the barrel on that Draw Day. A Selected Member is only eligible to win one Prize Draw for the Draw Day of the Promotional Period.

Prize Draws

9. The Promoter will conduct Prize Draws on Saturday 20 April, 2019 at 1:00pm, 2:00pm, 3:00pm, 4:00pm and 5:00pm at the Draw Location (each a ‘**Prize Draw**’).
10. At each Prize Draw, the name and membership number on the first correctly drawn and valid Entry selected from all Entries in the barrel and received in the relevant Entry Period (“**Selected Member/s**”) will be announced over the public address system at the Draw Location. The Promoter reserves the right to announce the name of Selected Members at other locations throughout The Ville.

11. Selected Members must be “present at the relevant Prize Draw” in accordance with **Condition 13** to be eligible to win. If a Selected Member is not “present at the Prize Draw”, **Condition 14** will apply and that Entry will be returned to the barrel to be eligible for the remaining Prize Draws on that Draw Day.
12. The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of The Ville.

Present at the Prize Draws

13. To be deemed “present at the Prize Draw” the Drawn Entrant must present themselves to a representative of the promoter at the Draw Location at The Ville within two (2) minutes of their name being announced and provide suitable identification in accordance with **Condition 18 and 19** (“**Winner**”). Drawn Entrants are not permitted to send a proxy to claim a prize.
14. Identification

18. A Selected Member must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver’s license) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
19. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a Selected Member is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

General

20. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
21. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax liability or implication which attaches to a prize is the responsibility of the selected member claiming that Prize.
22. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot

be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the willful or negligent acts or omissions of the Promoter. 23. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.

To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions in its sole and absolute discretion.
25. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
26. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion. In the event of any technical difficulties with the kiosk, the Promoter reserves the right to adopt a manual process of generating entries.
