

## CONDITION OF ENTRY

### [Aztec Gold] – Thursdays in January, 2021

**Promoter:** Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thies Drive, Townsville, Queensland, 4810.

#### Promotional Period and Location

1. The Aztec Gold promotion (“**Promotion**”) commences at 9.00am and concludes at 21.00pm on Thursday 7, 14, 21 and 28 January, 2021 (“**Promotional Period**”).
2. Tournament games will take place on the jackPod machines in the Promo Zone located on The Ville Main Gaming Floor (“**Draw Location**”).
3. Second chance Prize Draws will be conducted on the main gaming floor at The Ville (“**Draw Location**”).

#### Eligibility to Enter

4. In order to participate in the Promotion, a person must:
  - a) be 18 years of age or over;
  - b) be a current Member, Preferred, Executive, Director, President or Chairman member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promoter) (each a “**Membership Card**”);
  - c) are entitled to access the draw location; and
  - d) not be the subject of an exclusion direction of self-exclusion order pursuant to the Casino Control Act 1982 (Qld).
  - e) A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.
5. The Promoter reserves the right to refuse any person participation in the Promotion.

#### Entry and Entry Periods

6. An Eligible Entrant must present themselves at the jackPod machine in the Promo Zone between 9.00am to 20.59pm for each Promotion Period (“**Promotional Period**”).
7. The Promoter will have representatives to assist the Eligible Entrant in playing the jackPod machines with the game “Aztec Gold”.
8. Each Eligible Entrant may only qualify to have a maximum of one attempt during each Promotional Period. Once “Aztec Gold” game has been played, an entrant will receive a second chance ticket for the “Weekly Prize Draws” which then needs to be placed in the barrel located in the Promo Zone.
9. Entries close 1 minute prior to each of the Weekly Prize Draws.
10. An Entry is only valid for the next Prize Draws on that Draw Day to be held after that Entry is submitted, and is not valid for any subsequent Prize Draws on other days.

#### Conduct of the Prize Draw
