

CONDITION OF ENTRY

[Reno Rumble] – Sunday in March, 2021 –

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thies Drive, Townsville, Queensland, 4810.

Promotional Period and Location

1. The Reno Rumble promotion (“**Promotion**”) commences at 9.00am and concludes at 21.00pm on Sunday 7, 13, 21 and 28 March, 2021 (“**Promotional Period**”).
2. Tournament games will take place on the jackPod machines in the Promo Zone located on The Ville Main Gaming Floor (“**Draw Location**”).

Eligibility to Enter

3. In order to participate in the Promotion, a person must:
 - a) be 18 years of age or over;
 - b) be a current Executive, Director, President or Chairman member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promotor) (each a “**Membership Card**”);

6. The Promoter will have representatives to assist the Eligible Entrant in playing the jackPod machines with the game “Treasure Trove”.
7. Each Eligible Entrant may only qualify to have a maximum of one attempt during each Promotional Period. Once “Treasure Trove” game has been played.
