

CONDITIONS OF ENTRY

[Treasure Tuesdays] – March, 2021 - Member, Preferred, Executive or Director

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

Promotional Period

1. The [Treasure Tuesdays] promotion (“**Promotion**”) commences at [13.00pm] on Tuesday 2 March, 2021] and concludes once the final prize draw has been completed on Tuesday 30 March, 2021. (“**Promotional Period**”).
2. During the Promotion Period, Prize Draws will be conducted approximately every 60 minutes from [1:00pm – 9.00pm] (each a “**Prize Draw**”) on the main gaming floor at The Ville (“**Draw Location**”) on Tuesday 2, 9, 16, 23 and 30 March, 2021 during the Promotional Period (each a “**Draw Day**”).

Eligibility To Enter

3. In order to participate in the Promotion, a person must:
 - a) be 18 years of age or over;
 - b) are a Member, Preferred, Executive or Director level of the Vantage Rewards program operated by the Promoter and have a current Vantage Rewards membership card (with selective criteria chosen by the Promoter) (each a “**Membership Level**”); and
 - c) are entitled to access the draw location; and
 - d) not be the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld).

A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.

4. The Promoter reserves the right to refuse any person participation in the Promotion at any time.

Entries and Entry Periods

5. **For the Weekly Prize Draws**, one (1) entry (“**Entry**”) will be automatically generated on behalf of an Eligible Entrant for every \$5 Theoretical Spend based on game play (when the Eligible Entrant’s current Vantage Rewards card is correctly inserted into the gaming machine or registered at a gaming table). Table Games play is based on estimated average bet as determined by gaming staff.
6. Entry Periods for the Weekly Prize Draws are from 3 hours prior to each draw on the Draw Day (“**Entry Period**”). Entries will only qualify for the prize draws conducted on that respective days.

Conduct of the Prize Draws

7. The Promoter will conduct the Weekly Prize Draws approximately every sixty (60) minutes at 1.00pm, 2.00pm, 3.00pm, 4.00pm, 5.00pm, 6.00pm, 7.00pm, 8.00pm and 9.00pm (each a “**Prize Draw**”).
8. The Drawn Entry must be verified by two (2) representatives of The Ville to ensure the correct name is announced.
9. The name (and membership number if relevant) of the Eligible Entrants identified on the Drawn Entry will be announced on the PA System (“**Drawn Entrant**”). The Promoter cannot guarantee that announcements can be heard in all parts of the Draw Location or throughout the remainder of the venue during the Prize Draw announcements.
10. The Promoter reserves the right to announce the name of Selected Members at other locations throughout The Ville.
11. Selected Members must be “present at the relevant Prize Draw” in accordance with **Condition 13** to be eligible to win. If a Selected Member is not “present at the Prize Draw”, **Condition 12** will apply and that Entry will be returned to the barrel to be eligible for the remaining Prize Draws on that Draw Day.
12. If a Selected Member does not satisfy **Condition 13** or does not otherwise satisfy these Conditions of Entry, redraws will take place until a Selected Member who satisfies the requirements of these Conditions of Entry (including by being “present at the Prize Draw”) is drawn for each of the relevant Prize Draws.

13. To be deemed “present at the Prize Draw” the Drawn Entrant must present themselves to a representative of the promoter at the Draw Location at The Ville within two (2) minutes of their name being announced and provide suitable identification in accordance with **Condition 17 and 18 (“Winner”)**. Drawn Entrants are not permitted to send a proxy to claim a prize.
- a. In the circumstance that the Prize Draw location is at capacity, an announcement will be made over the PA system to Level 3. The Drawn Entrant must present themselves within five (5) minutes of their name being announced and provide suitable identification in accordance with **Condition 17 and 18 (“Winner”)**.

Prizes

14. The total prize pool is \$1,875 Cash and 3,750 Vantage Dollars.

15. Winners will receive their Prize after their identity has been confirmed in accordance with **Condition 17 and 18**.
16. All Prizes must be taken as stated and cannot be exchanged for alternate prizes or offers. Any tax implication or liability that attaches to a Prize will be the sole responsibility of the relevant winner.

Identification

17. An Eligible Entrant must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver’s licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
18. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of an Eligible Entrant is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

Invalid Draws/Entries

19. If an Entry is gained by means other than in accordance with these Terms and Conditions, the Entry will be deemed invalid.
20. If any drawn entry for a Prize Draw is not completed properly, is illegible, not original, appears to have been tampered with or is otherwise invalid in accordance with these terms and conditions, The Ville reserves the right to refuse that drawn entry and deem it invalid.

General

21. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
22. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter. To avoid any doubt, the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.

23. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.
24. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions in its sole and absolute discretion.
25. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
26. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion. In the event of any technical difficulties with the Casino Management System the Promoter reserves the right to adopt a manual process of generating Entries.
27. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
28. Drawn Entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Drawn Entrant. The names of Drawn Entrants will not be published without their consent except as announced at the Draw Location.
29. Participation in the Promotion indicates acceptance of the terms and conditions governing the Promotion. These terms and conditions will be available at the Vantage Rewards Customer Service Desk at The Ville throughout the Promotion Period.
30. By participating in this Promotion, each entrant's entry/entries becomes the property of the Promoter and may be
