CONDITIONS OF ENTRY

Promotional Period

- 1. The A Day at the Races promotion ("**Promotion**") commences at 10.00am and concludes once the final prize draw has been conducted at 14.00pm Friday 3, 10, 17, 24 September, 2021 ("**Promotional Period**").
