

CONDITION OF ENTRY

[Craze Claw] – Mondays in July, 2022 - All Tier Promotion (excluding Magnetic VIP and Orpheus VIP)

Promoter: Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thies Drive, Townsville, Queensland, 4810.

Promotional Period and Location

1. The Craze Claw promotion (“**Promotion**”) commences at 9.00am on Monday 11th July, 2022 and concludes at 15.00pm on Monday 25th July, 2022 (“**Promotional Period**”). *Not valid Monday 4th July, 2022.*
2. Tournament games will take place on the jackPod machines in the Promo Zone located on The Ville Main Gaming Floor and The Orpheus Room (“**Draw Location**”).

Eligibility to Enter

3. In order to participate in the Promotion, a person must:
 - a) be 18 years of age or over;
 - b) be a current Member, Preferred, Executive, Director, President, Platinum, Chairman or Diamond member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promotor) (each a “**Membership Card**”);
 - c) are entitled to access the draw location; and
 - d) not be the subject of an exclusion direction of self-exclusion order pursuant to the Casino Control Act 1982 (Qld).
 - e) A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.
4. The Promoter reserves the right to refuse any person participation in the Promotion.

Entry and Entry Periods

5. An Eligible Entrant must present themselves at the jackPod machines between 9.00am to 12:00pm and 12:00pm to 15.00pm each a Promotion Period (“**Qualifying Period**”).
6. The Promotor will have representatives to assist the Eligible Entrant in playing the jackPod machines with the game “Craze Claw”.
7. Each Eligible Entrant may only qualify to have a maximum of three attempts during each Qualifying Period.
8. Participation closes 1 minute prior to each of the Weekly Prize Draws, when all current games will finalise.
9. At the end of each “Craze Claw” game the Eligible Entrant will have a point score based on the play session.
10. At 12:00pm and 15:00pm, prizes will be awarded to the Eligible Entrants bases on the highest point score in descending order. Example the highest point score is awarded 1st Place and the second highest point score is awarded 2nd place etc
11. The point score is based on individual “Craze Claw” game and not an accumulation of points.
12. The prizes will be added onto the Eligible Entrant’s membership account after the prizes have been determined.
