## **CONDITIONS OF ENTRY**

[The Ville Lottery] - July, 2022.

**Promoter:** Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

#### **Promotional Period and Location**

- 1. The Ville Lottery promotion ("**Promotion**") commences at 9.00am and concludes once the final prize draw has been conducted at 17.00pm Saturday 2, 9, 16, 23 & 30 July, 2022 ("**Promotional Period**").
- 2. Prize Draws will be conducted on the main gaming floor at The Ville ("Draw Location").

## **Eligibility to Enter**

- 3. In order to participate in the Promotion, a person must:
  - a) be 18 years of age or over;
  - b) be a current Executive, Director, President, Platinum, Chairman or Diamond member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promotor) (each a "Membership Card"); are entitled to access the draw location; and
  - c) not be the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld).

A person who meets the above criteria will be referred to as an "Eligible Entrant".

4. The Promoter reserves the right to refuse any person participation in the Promotion at any time.

## **Entry and Entry Periods**

- 5. An Eligible Entrant must present themselves at the Vantage Rewards Desk between 9.00am to 16.59pm for each Promotion Period ("Qualifying Period").
- 6. The Promotor will have representatives to assist the Eligible Entrant in selecting a pop out ticket from their qualifying barrel and also handing (1) entry ("Entry") for the Weekly Prize Draw using the membership records of those Eligible Members that are held by the Promoter.
- 7. Eligible Entrants may only qualify to receive one pop-out ticket during each Qualifying Period.
- 8. Entries close 1 minute prior to each of the Weekly Prize Draws.

## **Conduct of the Prize Draw**

If a Selected Member does not satisfy **Condition 15** or does not otherwise satisfy these Conditions of Entry, redraws will take place until a Selected Member who satisfies the requirements of these Conditions of Entry (including by being "present at the Prize Draw") is drawn for each of the relevant Prize Draws.

#### **Present for the Prize Draws**

- 17. To be deemed "present at the Prize Draw" the Drawn Entrant must present themselves to a representative of the promoter at the Draw Location or the Orpheus Room Concierge Desk at The Ville within two (2) minutes of their name being announced and provide suitable identification in accordance with **Condition 22 and 23** ("Winner").

# Identification

- 25. If any drawn entry for a Prize Draw is not completed properly, is illegible, not original, appears to have been tampered with or is otherwise invalid in accordance with these terms and conditions, The Ville reserves the right to refuse that drawn entry and deem it invalid.

#### General

- 26. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
- 27. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the wilful or negligent acts or omissions of the Promoter.
