CONDITIONS OF ENTRY

[A Day at the races] - Fridays in August, 2022 - All tier promotion

Promotional Period

- 1. The A Day at the Races promotion ("**Promotion**") commences at 10.00am and concludes once the final virtual race has been conducted at 14.00pm Friday 5, 12, 19 & 26 August, 2022 ("**Promotional Period**").
- 2. Virtual races will be conducted on the main gaming floor at The Ville ("**Draw Location**") and The Orpheus Room.

Eligibility To Enter
