

## CONDITIONS OF ENTRY

### [Ladies Night] – Tuesdays in August, 2022 – All tier promotion

**Promoter:** Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

#### Promotional Period

1. The “Ladies Night” promotion (“**Promotion**”) commences at [6pm] [Tuesday 2<sup>nd</sup> August, 2022] and concludes at the conclusion of the 9.00pm prize draw on Tuesday 30<sup>th</sup> August, 2022. (“**Promotional Period**”).
2. Prize draws will be conducted every hour from 7.00pm to 9.00pm (each a “**Prize Draw**”) during the Promotional Period on the main gaming floor at The Ville (“**Draw Location**”).

#### Entry Requirements

3. In order to participate in the Promotion, a person must:
  - a) be 18 years of age or over;
  - b) be a current Member, Preferred, Executive, Director, President, Platinum, Chairman, Diamond, Magnetic VIP or Orpheus VIP member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promotor) (each a “**Membership Card**”);
  - c) be a patron participating with credit in an Electronic Gaming Machine or a valid bet in an eligible Table Game; and
  - d) are entitled to access the draw location; and
  - e) not be the subject of an exclusion direction or self-exclusion order pursuant to the *Casino Control Act 1982* (Qld).A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.
4. The Promoter reserves the right to refuse any person participation in the Promotion at any time.

#### Entries

5. An Eligible Entrant may earn entries in the Promotion through playing eligible gaming machines (“**EGM**”) and table games on the Main Gaming Floor and in the Magnetic Room. *Excludes Fully Automated Tables Games (FATGs)*.
6. Eligible table games are: Blackjack, Roulette, Three Card poker, and Mini Baccarat (“**Table Games**”).
7. Earn entries from 6pm to 5 minutes before the Prize Draws.
8. Winning entries from the Prize Draws will be re-entered into the barrel for the following prize draws on that Draw Day only.
9. Eligible Entrants who are participating with credit in an eligible electronic gaming machine will earn one Entry for the Prize Draws when they have received a feature on their electronic gaming machine. When a feature is won the patron is required to yell out “TICKET” and a representative from The Ville will approach the patron and award the Entry.
10. Eligible Entrants who are participating with a valid bet in an eligible Table Game will earn one Entry for each of the following selected plays on a rated table game during an Entry Period on a Draw Day:
  - f) Blackjack- when anyone gets a blackjack (including the dealer);
  - g) Roulette- when the dealer spins any number ending in 0 (0,10,20,30);
  - h) Three Card Poker- when anyone in the hand receives a Flush or higher including the Dealer’s hand;
  - i) Mini Baccarat- when a Natural 9 is dealt;
  - j) The Ville Wheel – when NSW 3-1 is spun.
11. Eligible Entrants must complete their name and member number on Entry Ticket and place in the barrel at the Prize Draw Location (“**Barrel**”) during the Entry Period on each Draw Day.
12. If the winner is not present for the Prize Draws, their entry is placed back in the barrel for the upcoming Prize Draws on that Draw Day. At the conclusion of the 9pm Prize Draw all entries are discarded and will not be carried over to the next Draw Day.

## Conduct of Prize Draws

13. Should the Draw Location be filled to capacity for any Prize Draw, the Promoter will direct excess audience members to an additional venue at The Ville to attend the Prize Draws.
14. At each Prize Draw, one (1) Entry will be selected randomly from the Barrel ("**Drawn Entry**"). The Drawn Entry must be verified by two (2) representatives of The Ville to ensure the correct name is announced.
15. The name of the Eligible Entrants identified by the first one (1) randomly selected Entries will be announced at the Draw Location ("**Drawn Entrant**"). The Promoter cannot guarantee that announcements can be heard in all parts of the Draw Location or throughout the remainder of the venue during the Prize Draw announcements.
16. Eligible Entrants who have entered the Prize Draw must be "present at the Prize Draw" for a chance to win. To be deemed "present at the Prize Draw" the Drawn Entrants must present themselves to a The Ville representative at the Draw Location at The Ville within two (2) minutes of their name being announced and provide suitable identification in accordance with **Conditions 21 and 22**. Drawn Entrants are not permitted to send a proxy to claim a prize.
17. If a Drawn Entrant does not comply with **Condition 16**, the prize is redrawn until a winner is found that complies.

## Prizes

18. Winners at each Prize Draw, will receive:
  - 7pm: Guess bag valued from \$199 and 250 Vantage Dollars
  - 8pm: Orotan handbag valued from \$269 and 500 Vantage Dollars
  - 9pm: Designer handbag valued from \$1,820 and 1,000 Vantage Dollars (each a "**Prize**") .

Total prize pool each week is up to \$5,618 in prizes
19. Each winner will receive their Prize after their eligibility to win has been confirmed in accordance with **Conditions 21 and 22**.
20. All Prizes must be taken as stated and cannot be exchanged for alternate prizes or offers. Any tax implication or liability that attaches to a Prize will be the sole responsibility of the relevant Winner.

## Identification

21. A Drawn Entrant must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's licence) with an undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.
22. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a Drawn Entrant is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

## Invalid Draws/Entries

23. If an Entry is gained by means other than in accordance with these Terms and Conditions, the Entry will be deemed invalid.
24. If any Drawn Entry for a Prize Draw is not completed properly, is illegible, not original, appears to have been tampered with or is otherwise invalid in accordance with these terms and conditions, the Promoter reserves the right to refuse that Drawn Entry and deem it invalid.

## General

25. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
26. Prizes must be taken as stated and cannot be exchanged or redeemed for alternate prizes. Any tax

liability or implication which attaches to a prize is the responsibility of the selected member claiming that Prize.

27. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the willful or negligent acts or omissions of the Promoter. To avoid any doubt, the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.
28. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.
29. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions in its sole and absolute discretion.
30. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
31. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion. In the event of any technical difficulties with the kiosk, the Promoter reserves the right to adopt a manual process of generating entries.
32. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
33. Drawn entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant selected member. The names of drawn entrants will not be published without their consent except as announced at the Draw Location.
34. Participation in the Promotion indicates acceptance of the terms and conditions governing the Promotion. These terms and conditions will be available at the Vantage Rewards Customer Service Desk at The Ville throughout the Promotion Period.
35. By participating in this Promotion, each entrant's entry/entries becomes the property of the Promoter and may be used for the Promoter's business analysis and marketing purposes in accordance with the Promoter's privacy statement which can be viewed at [the-ville.com.au](http://the-ville.com.au). Privacy law allows entrants to access their personal information held by the Promoter in certain circumstances. Failure to supply the personal information requested may result in an entry being deemed invalid.
