# **CONDITION OF ENTRY**

### [Jelly Kingdom] - Wednesdays in August, 2022

#### **Promotional Period and Location**

- 1. The Jelly Kingdom promotion ("**Promotion**") commences at 12.00pm Wednesday 3<sup>rd</sup> August, 2022 and concludes at 15.00pm on Wednesday 31<sup>st</sup> August, 2022 ("**Promotional Period**").
- 2. Tournament games will take place on the jackPod machines in the Promo Zone located on The Ville Main Gaming Floor and The Orpheus Room ("**Draw Location**").

# **Eligibility to Enter**

- 3. In order to participate in the Promotion, a person must:
