CONDITIONS OF ENTRY

1. Promotional Period

- 1.1. The **[Lucky Pop]** promotion ("Promotion") commences at [18:00] on Sunday 26 October, 2025 and concludes once the final prize draw has been completed on Sunday 30 November, 2025. ("Promotional Period").
- 1.2. During the Promotion Period, Prize Draws will be conducted approximately every hour from [14:30 18:30] (each a "**Prize Draw**") in The Orpheus Room at The Ville ("**Draw Location**") on 2, 9, 16, 23 & 30 November, 2025 during the Promotional Period (each a "Draw Day").

2. Eligibility To Enter

- 2.1. In order to participate in the Promotion, a person must:
 - a) be 18 years of age or over;
 - b) be a current Platinum, Chairman or Diamond member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the Promoter) (each a "**Membership Level**");

2.2. The Promoter reserves the right to refuse any person participation in the Promotion at any time.

3. Entries and Entry Periods

- 3.1. An Eligible Entrant may earn entries in the **Qualifying Prize Draws** through playing Electronic Gaming Machines ("**EGM**"), Fully Automated Table Games ("**FATG**") and Table Games.
- 3.2. **For Prize Draws**, one (1) entry ("**Entry**") will be automatically generated on behalf of an Eligible Entrant for every \$5 Theoretical Spend based on game play (when the Eligible Entrant's current Vantage Rewards card is correctly inserted into the EGM or registered at a gaming table). - 8.1. In the case of a Proxy for an Eligible Entrant, the proxy nomination must be completed, signed and lodged with the Promoter no less than 1 hour prior to the draw.
- 8.2. Only Diamond Tier level members may nominate a proxy to represent them at the draw.
- 8.3. The prize for the draw will not be issued to the Proxy and will only be issued to the Prize Winner. Vantage Dollar and cash prizes will be added to the Prize Winners account, where all other prizes will be held waiting for collection by the Prize Winner, who will need to provide identification in accordance with conditions under item **7. Identification**, when collecting the prize.

9. Invalid Draws/Entries

10. General
