CONDITION OF ENTRY

1. Promotional Period and Location

- 1.1. The Pickin' Chicken promotion ("**Promotion**") commences at 09:00 on Wednesday 5 November 2025 and concludes at 15:00 on Wednesday 26 November 2025 ("**Promotional Period**").
- 1.2. Tournament games will take place on the jackPod machines in the Promo Zone located on The Ville Main Gaming Floor and The Orpheus Room ("**Draw Location**").

2. Eligibility to Enter

- 2.1. In order to participate in the Promotion, a person must:
 - a) be 18 years of age or over;
